- 3. At the discretion of Best Rental Services Inc., any account with a delinquent balance may be placed on a cash basis any time, and the equipment picked up without notice.
- 4. Best Rental Services Inc. files preliminary lien notices and mechanics liens whenever necessary or required by law. This is a company policy, and is not a reflection of your credit standing.
- For each delinquent account, customer agrees to pay a monthly service charge equal to 2% (24% per annum) of the past due balance or the maximum 5. service charge permitted by law in the province where the contract is signed.
